## Minutes

The meeting was called to order at 6:04 pm PST.

- A. General business
  3. Actions taken between meetings:
    - a. Minutes of the zone meeting held in Dallas, TX on September 14 were approved via email.
  4. NW Zone Chatter Newsletter
    - a. LMSC reports are due to the chair by December 6.
  5. Zone Chair report – Sally Dillon
    - a. As a new cycle has begun, Sally appointed Ken Winterberger (treasurer), Hugh Moore (webmaster), and Steve Darnell (record keeper) for 2-year terms.
    - b. The next NW Zone meeting is scheduled for Sunday, March 4, 2018 at 6 pm PST.
    - c. The LMSC Standards survey will take place in early 2018. Let Sally know if there are deficiencies from the last survey that you'd like to discuss. She reminded everyone that their officers need to register with USMS by January 1.
  6. Financial report – Ken reported that the zone has account has a balance of \$5774.23. He has not yet received convention reimbursement requests from SR and MT. The Reimbursement form can be obtained from Ken or downloaded from the website at northwestzone.org. Sandi asked if Ken will be billing the Oregon treasurer for the SCM zone meet surcharge and he responded that a check should be sent directly to him, payable to USMS with NW zone noted on the memo line. Ken noted that while some people have expected a bill, the meet treasurer should submit this on their own. Sally noted that this is the last time a zone surcharge will be collected. **MSA to approve the treasurer's report as submitted.**
  7. Webmaster report – Hugh Moore wasn't present but Sally noted that he is keeping the website up to date. Aaron said that UT has a new webmaster and a new website is coming soon. Sally suggested that the new web link be submitted to Hugh for posting on the zone web page.
  8. Record keeper report – Steve Darnell reported via email.
    - a. SCM records are current, including results from the November 2017 Zone Championship meet in Hood River, OR, and the November 2017 PSM meet in Federal Way, WA.
    - b. LCM records are current, including results from the August 2017 USMS National Championship meet in Minnesota, and the August 2017 Zone Championship meet at Mt. Hood Community College, OR.
    - c. SCY records are current, including results from the April 2017 USMS National Championship meet in Riverside, CA.
    - d. There were 54 new Zone SCM records set at the recent PSM Championship meet in Federal Way, which must be a new record in itself!
    - e. There are no significant unresolved issues at this point.
    - f. Thank you to Hugh Moore for posting updated Zone record files to the Zone website so quickly!

Aaron asked if the zone records get posted automatically to the USMS site. Sarah said they are connected but swimmers need to notify their LMSC Records and Tabulation person if they are competing out of the LMSC or USMS. Aaron was wondering if recent state records got into the database.

9. NW Zone At Large Director report – Sarah Welch reported that since convention, committee assignments have been made by USMS President Patty Miller. People who requested committee spots received one, but not always on the committee that they requested due to the need to see that all committees were well balanced. The National Office sent out the notices notifying all who were appointed. The Board has established two Task Forces: 1) Convention, which is being led by Ed Tsuzuki and 2) Volunteers, which is being led by Laura Winslow.

Aaron brought up an issue Utah is having regarding dual sanctioning meets with College Club Swimming (CCS). There doesn't seem to be a plan in place to allow this since CCS is not like USA-Swimming. Donn had the understanding that CCS swimmers were also USMS members but that is apparently not the case. Since they already pay dues to CCS, many are not inclined to also join USMS. Aaron will send Donn and Sarah an email with details so they can bring it up with the USMS Board. Paige suggested that Aaron and others with similar concerns contact Onshalee at the National Office as she is well acquainted with CCS and can answer their questions. Sandi asked about the status of the new USMS website and Donn replied that as per an update during a recent Executive Committee call, the website is slated to go live February 1.

10. 2017 NW Zone Championship events

- a. SCM at Hood River, OR – Sandi Rousseau reported that there were 87 swimmers at the meet; most from Oregon plus a few others. The meet garnered good reviews from OR evaluators. Next year they will have a 1-day meet in HR and it will be the same weekend.
